THIS IS THE LAST WILL AND TESTAMENT  
of me RICHARD POULTON of No 1 Rosemont Road Acton in the County of Middlesex Gentleman

I revoke all wills and testamentary dispositions heretofore made by me I appoint my wife Alice Jane Poulton my son Albert Thomas Poulton and my son in law Harold Edward Makepeace (who and the survivor of whom and all other the trustee or trustees for the time being hereof are hereinafter referred to as "my trustees") to be the EXECUTRIX and EXECUTORS and trustees hereof I give to my said wife Alice Jane Poulton a legacy of one hundred pounds free of duty to be paid to her immediately after my death I give and bequeath all my household furniture plate linen china glass books pictures and all other articles of personal household or garden use or ornament to my said wife during her life so long as she shall remain my widow she keeping the same in good repair and insured against fire in the full value thereof at her own cost in the names

of my trustees And I declare that my said wife shall not be bound to sign an inventory of such furniture and effects and that it shall not be obligatory on the trustees to make an inventory or to see to the repair or insurance of the said chattels and that they shall not nor shall either or any of them be personally liable by reason of the neglect or omission of my said wife to repair or insure such chattels or by reason of any loss resulting therefrom but that nevertheless my trustees may take such steps as they shall think fit for the protection and preservation of the said furniture and effects And from and after the death or remarriage of my said wife whichever shall first happen I give to my daughter Edith Marion Poulton (if she shall be unmarried at the date of the death or remarriage of my said wife) my Bechstein piano now in the dining room and also all the furniture of and in her bedroom including any portions of the bedroom suite belonging to her room which may be in other parts of the house And I direct that the remainder of my furniture and household effects shall fall into and form part of my general residuary estate And as to all the rest residue and remainder of my estate and effects of whatever nature or kind the same may be and wheresoever situate I give devise bequeath and appoint the same unto my trustees Upon trust that my trustees shall sell call in collect and convert the same into money but so that no portion of my residuary estate other than my business or businesses shall be sold or realised during the widowhood of my said wife without her consent in writing it being my wish that during her widowhood my estate shall be left as far as may be in the same state of investment as at my death except as to the said businesses which I direct my trustees to sell as soon as conveniently may be after my decease And I direct my trustees to hold any moneys arising from such sale calling in collection and conversion and the ready money of which I shall be possessed at my death (after payment thereof of my just debts funeral and testamentary expenses and death duties and the legacies bequeathed by this my will or any codicil hereto) Upon trust to invest the same upon any investments allowed to trustees by law or in or upon copyhold leasehold or chattel real securities in Great Britain such leaseholds or chattels real having not less than sixty years to run at the time of such investment being made and to pay or apply the income arising from any such investments and from any portions of my residuary estate that may remain unconverted to my said wife during her life so long as she shall continue my widow And I declare that the income of my estate however invested shall from my death be treated and applied as income and no part thereof shall be added to capital And from and after the death or remarriage of my said wife whichever shall first happen I give my leasehold dwellinghouse and premises No 23 Mansell Road Acton aforesaid to my said daughter Edith Marion Poulton or in the event of the said leasehold dwellinghouse and premises having been previously sold by my trustees then I give to my said daughter Edith Marion Poulton in lieu of the said leasehold dwellinghouse and premises a sum of money equal to the net proceeds of sale of the said premises after deducting

all expenses costs and commission connected with the said sale but in either case the gift of the said leasehold dwellinghouse and premises or the sum of money in lieu thereof shall take effect only if my said daughter Edith Marion Poulton shall be unmarried at the date of the death or remarriage of my said wife And I direct my trustees to pay the following legacies namely To my sister Sarah Ann Hill the sum of twenty pounds free of duty And to each of the three children now living of my said son Richard Grady Poulton ten pounds free of duty And as to the remainder of my residuary estate I direct my trustees to hold the same in trust for my six children Alice Hephzibah Makepeace (the wife of the said Harold Edward Makepeace) Leila Grace Poulton the said Edith Marion Poulton Ivy Clarice<sup>May</sup> Poulton the said Albert Thomas Poulton and Wilfred Frank Poulton as tenants in common in equal shares And I declare that the reason for my said son Richard Grady Poulton not sharing with my other children in my residuary estate is that he has already during my lifetime received a larger portion than will fall to any of my other children under this my will IN WITNESS whereof I have hereunto set my hand this thirtieth day of July one thousand nine hundred and fourteen R POULTON - Signed by the above named Richard Poulton as and for his last will and testament in the presence of us both present at the same time who in his presence at his request and in the presence of each other have hereunto subscribed our names as witnesses W A G DAVIDSON Acton W Solicitor -- Wm MORGAN his clerk
